With effect from Monday 24th June 2024 the Subsistence Allowance will be £50.65 per night.

WR.20 SICK PAY

WR.20.4 Amount of Payment

With effect from Monday 24th June 2024, Industry Sick Pay, which is in addition to SSP, will be £163.36 per week.

WR.18 ANNUAL HOLIDAYS

With effect from 1st January 2025 the entitlement to industry holidays will be increased from the current 22 days holiday to 23 days holiday. Public holiday entitlement remains unchanged at 8 days.
